




Hallo !

En motsats til velferdsstaten er nattvekterstaten.



ID - NUMBER*

In Norway, identification numbers is used to identify inhabitants. Many public and private sector organisations require to have a Norwegian identification number in order to gain access to their services. Once you have it, you keep it for your whole life.

Now that I understand more how the system is working in a general way, I looked for more persons point of views, and asked few of my Norwegian friends about it.

Adélie : Globally, what do you think about the Norwegian Velferdsstaten ?

Sofie : I think the Norwegian velferdssstat is a great thing, and I know it's not feasible to achieve in every other country, but I think it could be at least partially achieved in a lot of industrial countries. It's all about taxes, and the state owning the country's resources and that the profit off those benefitting the citizens and not big corporations owned by a few fat cats. If you reduce the influence of capitalism on society and let the state invest in the population's future it can be

done. An investment in universal education and healthcare are especially important.

A : Do you feel helped enough by the state ? And if not, what would you change ?

S : The state has never let me down, and I never fear that I will find myself in any real danger concerning education, health, or housing. I think large corporations could be restricted further.

A : Do you sometimes compare the situation in Norway to other countries ? Like «this is better dealt with somewhere else» ?

S : The only think that comes to mind is how dental care is state funded in the UK, whereas here it's only partially funded.






